The journal *Studien zur Indologie and Iranistik* publishes articles on various aspects of Indian culture – religion, language, literature, philosophy, arts, sciences (to name the most important aspects) – and history and art history, classical and modern, and on aspects of Iranian culture, particularly those with a bearing on Indian culture.

This journal does not publish any reviews or review articles. Books sent unsolicited for the purpose of being reviewed will not be returned.

### Manuscript Submission

Authors are requested to submit their articles in electronic form (in RTF or MS Word format running under the operating systems of Windows 2000, ME or XP) in addition to a PDF file (to be sent by e-mail) and a paper printout (A4, printing on one side only, with broad margins for reviewers' remarks). All material including notes and references should be double-spaced.

The author is requested to give the exact title of the article, the author's full name, his or her affiliation and the full address, either the private or the institutional one. If wished also the email address may also be given.

Once accepted for publication, the author should make absolutely sure that (s)he sends the latest version of his or her manuscript.

For the purpose of reviewing, articles submitted for publication should be sent to both editors.

### Manuscript Presentation

- (1) Articles may be written in English, French or German. Those in French and German should preferably include a short English summary.
- (2) Please do not use any formatting at all for both text and footnotes.
- (3) Subdivide your article into paragraphs (indicated by two returns) which should be numbered consecutively and, if necessary, graded. Two levels should suffice, but a third may be used if necessary (1., 2., 3. or 1.1., 1.2., 1.3., 2.1. or 1.1., 1.1.1,

1.1.2, 1.2.).

- (4) Please use Gandhari Unicode as the one and only font. It can be down-loaded from <http://depts.washington.edu/ebmp/software.php> (or from <http://www.indologie.uni-goettingen.de> under `Links´). Only one font size should be used for both the text and the footnotes, and in both use only normal Roman, italics and small capitals only (for names of modern authors, see 8, below).
- (5) Languages not using the Latin alphabet should be transliterated according to the internationally accepted system (for Sanskrit the system of the Poona Dictionary, for Iranian the Hoffmann-Narten system, for Tibetan the Wylie system, for Hindi the Sharma-Vermeer system, for Dravidian the Burrow-Emeneau system).
- (6) Use double quotation marks for direct quotation and single quotation marks for quotations within quotations. Single quotations marks should also be used for words or phrases employed in a special sense (e.g. for distancing). All citations should appear within the running text, longer ones should be set off from the rest of the text by left-indenting.
- (7) Please use footnotes which should be indicated by consecutive superscript numbers in the text. The very first footnote should contain acknowledgements of people, grants, and so on. In order to avoid an excessive number of footnotes please give short bibliographical references (e.g. „OLDENBERG 1917: 99-102“) within the text in round brackets (see 8, below).
- (8) References to books and articles should consist of the author´s surname (in small capitals) followed by the year of publication, and, in the case of articles, by a colon, a blank and the page number(s), all in brackets, e.g. „(see OLDENBERG 1917)“ or „(see BLOOMFIELD 1928: 212-214)“. Where there are more than two authors, only the first author´s name should be given, followed by `et al.` (e.g. see KIELHORN *et al.* 1903: 15-17). Please do **not** use abbreviations such as `op. cit.`, `loc. cit.`, `ibid.`, `passim` and the like.
- (9) Full details of all books and articles referred to in the text and in footnotes should be listed at the end of the article in a section entitled „References“ in strict alphabetical order. Titles of monographs, edited collections and abbreviations of journal titles are to be quoted in italics. These references should be arranged as in the examples below:

1928 The Home of the Vedic Sacrifice. *JAOS* 48 (1928) 200-224.

KUIPER, F. B. J.

1972 The Heavenly Bucket. *India Maior (Festschrift Jan Gonda)*. Leiden 1972, 144-156.

OLDENBERG, H.

1917 *Die Religion des Veda*. Berlin 1917.

Where the last word of the title of the article has been italicised, insert „In:“ before the title of the monograph, edited collection (etc.) in order to avoid two taggings in italics clashing:

2000 *Prajātantu*. In: *Harānandalaharī. Volume in Honour of Professor Minoru Hara on his Seventieth Birthday* (ed. by RYUTARO TSUCHIDA and ALBRECHT WEZLER). Reinbek 2000, 457-480.

- (1) Primary literature should be cited by means of common sigla without following a full stop (RV, AB, ChU, Mbh, R, KSS). If no standard siglum exists the author may create one which should be explained at the very end of the article in a list containing other symbols which have been employed.
- (2) The source of translations, if not the author's, should always be indicated. Syntactically necessary additions to translations made by the author, should be given within square brackets, explications and other additions within round brackets.
- (3) Authors have to seek permission themselves to reprint materials taken from other published works. Permission should be requested from the copyright holder.

### **Photographs and images**

Photographs and images can be inserted into the articles. Please use **JPEG** as format. A minimum of 600 dpi is required for black-and-white ones. For line drawings use 1200 dpi.

### **Proofs**

Two proofs will be sent back by e-mail. All authors are thus requested to give their current e-mail address(es). Corrected proofs should be returned within four weeks.

### **Free Copy**

One copy of the journal and a PDF file of the author's article will be provided free of charge.

Articles submitted to the *Studien zur Indologie und Iranistik* must not be offered to other journals.
